SCHOOL PROGRAM REPORTS/DISCUSSION:

Our Christmas TA Service Projects consisted of tying quilts, picking up trash along the street in front of the school, making Christmas cards for care centers and assisted living centers, and raking leaves on the school grounds.

The Faculty Auction raised \$3600 that was used to provide for 24 students in need. They received \$100 in gifts from a Secret Santa.

Attached is new information on COVID protocols/guidelines for the school district. It was discussed by Jena Nelson.

Night school was successful last quarter. Teachers provided classes Tuesday thru Thursday from 2:35 until 4:30 to help make up credits. This allowed students to take more than one night school class in different subjects. Several credits were earned.

We had 45 new students start at Millcreek in January. 24 of those being Sophomores that are only allowed to start in January or after.

Rusty presented an idea for spending next year's State Trust lands money. The focus center had one teacher retire this year and the one teacher and secretary seem to be handling it fine by themselves. Our school has a big need for mental health counseling and support. That money could be used to hire extra help in that area. The council was encouraged to bring any other ideas they have for using the money to be discussed and voted on at the March meeting.

The discussion was brought up to plan on a virtual Graduation again this year with the pandemic. A lot of our students and their parents appreciated how it was handled last year and would prefer to continue that way in the future. The students are filmed ahead of time and their families can be here to watch and then go to a reception area in the school to celebrate together. The video is made available for all students to watch on our actual graduation day where they can celebrate again if they wish.

The Health Department updated its guidelines for isolation and quarantine. The new guidance applies to both students and employees. A copy of the update is attached to this email.

In summary:

If you test positive for COVID-19 you are required to:

- Stay at home for 5 days from the day you were tested, even if you don't have symptoms or feel sick.
- You can leave your house after 5 days if your symptoms have improved (fever-free for at least 24 hours and your symptoms have improved). You must stay home for at least 5 days.
- You need to wear a mask around others for the 5 days after the time you were isolating in your home.
- We recommend you get a COVID-19 test before returning to your normal activities (work, school, etc.) to make sure you no longer are spreading the COVID-19 virus.
- Isolation is required for all people who test positive for COVID-19 regardless of whether they are vaccinated or unvaccinated.

Updated Utah Guidance on Isolation and Quarantine for the General Population and Students.

This guidance does not apply to healthcare workers, immunocompromised people, or people living or working in congregate settings (Ex: homeless shelters, correctional facilities)

Isolation: If you test positive for COVID-19

If you test positive for COVID-19 you are required to:

- Stay at home for 5 days from the day you were tested, even if you don't have symptoms or feel sick.
- You can leave your house after 5 days if your symptoms have improved (fever-free for at least 24 hours and your symptoms have improved). You must stay home for at least
- You need to wear a mask around others for the 5 days after the time you were isolating in your home.
- We recommend you get a COVID-19 test before returning to your normal activities (work, school, etc.) to make sure you no longer are spreading the COVID-19 virus.
- Isolation is required for all people who test positive for COVID-19 regardless of whether they are vaccinated or unvaccinated.

Quarantine: If you have been exposed to someone with COVID-19

- For people 18 years and older
 - o If you got a booster dose OR got a second dose of Pfizer or Moderna vaccine within the last 6 months OR got a J&J vaccine within the last 2 months:
 - You don't need to quarantine at home. You can continue to go to work and participate in activities outside of your house.
 - You should wear a mask for 10 days after your exposure.
 - We recommend you get tested 5 days after you are exposed to make sure you are not positive and possibly spreading the virus to others.
 - o If you have **not** gotten a booster dose <u>OR</u> got a Pfizer or Moderna vaccine more than last 6 months ago <u>OR</u> got the J&J vaccine more than last 2 months ago <u>OR</u> if you are unvaccinated:
 - You should stay at home for 5 days from the day you were exposed to COVID-19.





- You can leave your house after 5 days as long as you don't have any symptoms. You can return to work and participate in activities outside of your house wearing a mask.
- Wear a mask for 10 days after your exposure.
 - If you can't quarantine at home, you should wear a mask in public and around other people for the 10 days after your exposure.
- We recommend you get tested 5 days after you are exposed to make sure you are not positive and possibly spreading the virus to others.
- For people younger than 18 years:
 - o If you have gotten two doses of Pfizer or Moderna
 - You don't need to quarantine at home. You can continue to go to school, work, and participate in activities outside of your house.
 - You should wear a mask for 10 days after your exposure.
 - We recommend you get tested 5 days after you are exposed to make sure you are not positive and possibly spreading the virus to others.
 - If you have not gotten two doses of Pfizer or Moderna <u>OR</u> if you are unvaccinated
 - You should stay at home for 5 days from the day you were exposed to COVID-19.
 - You can leave your house after 5 days as long as you don't have any symptoms. You can return to work and participate in activities outside of your house if you wear a mask.
 - Wear a mask for 10 days after your exposure.
 - If you can't quarantine at home, you should wear a mask in public and around other people for the 10 days after your exposure.
 - Students may attend school if they wear a mask for 10 days after their exposure.
 - We recommend you get tested 5 days after you are exposed to make sure you are not positive and possibly spreading the virus to others.
